We would like to thank you for your timely responses to letters that have been sent previously but we do have another request we are hopeful you'll be able to help us with.

It's come to our attention that despite the UNMC Investigative Team having a conditional use permit that allows them to conduct testing on the feedlot near Mead, they are not being allowed to access the AltEn plant site. We believe it would be beneficial access to this area as well in order to do additional testing on the soil and the air in that particular spot.
