- c. DHHS: Esseks: Flood was harder on the SW systems than the drought. 95 systems were on the drought list last year, but they were all GW systems <a href="http://dhhs.ne.gov/publichealth/Pages/enh">http://dhhs.ne.gov/publichealth/Pages/enh</a> pws conindex.aspx
- d. NARD: Pat resigning at end of June to take over the GM position of Upper Niobrara White NRD; Many thanks;
  - i. EQUIP NWQ initiative targeting up to 4 basins per state: Cub Cr, Cottonwood Cr, Pigeon-Jones, + 1 more; Working to develop watershed mgmt plans (Pibel lake-Clear Cr; Lower Big Blue; Little Blue all working on adding plans; LPRCA developing one for the corridor); Getting EPA to agree to HUC8s or a corridor has been a process; <a href="http://www.nrcs.usda.gov/wps/portal/nrcs/detail/national/programs/fin-ancial/eqip/?cid=stelprdb1047761">http://www.nrcs.usda.gov/wps/portal/nrcs/detail/national/programs/fin-ancial/eqip/?cid=stelprdb1047761</a>
  - ii. LB516: Carlson bill to generate \$ for water research
  - iii. LB517: Carlson bill to create a water task force; Lathrop amendment to reduce representation from ~30 to 9 members; Future of the bill uncertain; Bill requires a final report by Dec 31, 2013 (Lot to get done in short time); Money source unknown
- e. LPSNRD: Ehrman LPS developing a voluntary IMP, mostly focused on quantity, but still pushing to include some quality; Public hearing phase right now; http://www.lpsnrd.org/IntegratedMgtPlan/impindex.htm
- f. NGPC: Tunink Reminder that if, during sampling activities, we come across any of Nebraska's aquatic invasive species (<a href="http://snr.unl.edu/invasives/invasiveaquatic.htm">http://snr.unl.edu/invasives/invasiveaquatic.htm</a>) to report it on the project website. Boat cleaning: Clean (Prefer vinegar over bleach; Hot water is best); Drain all liquids; and Dry

- 5. Open discussion: Special monitoring needs in the event of a 2013 drought
  - a. Monitoring the long-term ecological impacts. How long does it take a community to recover?
  - b. Would be very useful to have some way of predicting water temperature as a function of air temperature and flow rate for a given site.
  - c. Many of the management decisions during a drought are based more on water quantity than quality.

- i. Past experience shows that in a drought, the number of well permit requests goes up considerably.
- d. From a drinking-water quality perspective, there is less impact in Nebraska because most of the systems are GW.
