Natural Gas Service Providers and Their Prices in Nebraska 2007

In 2007, the <u>residential sector</u> paid an average of \$11.15 (including taxes) per thousand <u>cubic feet</u> for natural gas, the <u>commercial sector</u> paid \$9.16, the <u>industrial sector</u> paid \$7.97, and the <u>electric power sector</u> paid \$8.97.

The state's natural gas was supplied by nineteen companies whose average 2007 residential rates ranged from Hastings Utilities' \$6.85 to the City of Stromsburg's \$17.48 per thousand cubic feet. Commercial rates ranged from Hastings Utilities' \$7.76 to the City of Stromsburg's \$14.01. Rates for natural gas used by electric utilities ranged from Stuart Gas Company's \$1.66 to City of Wahoo's \$10.21. Industrial rates ranged from the City of Wisner's \$4.66 to the City of Superior's \$12.69.
