Natural Gas Service Providers and Their Prices in Nebraska 2008

In 2008, the <u>residential sector</u> paid an average of \$11.11 (including taxes) per thousand <u>cubic feet</u> for natural gas, the <u>commercial sector</u> paid \$9.62, and the <u>industrial sector</u> paid \$9.12. The <u>electric power sector</u> average price was withheld.

The state's natural gas was supplied by nineteen companies whose average 2008 residential rates ranged from Hastings Utilities' \$7.19 to the Stuart Gas Company's \$13.42 per thousand cubic feet. Commercial rates ranged from City of Wisner's \$5.94 to the City of Stromsburg's \$13.61. Rates for natural gas used by electric utilities ranged from Stuart Gas Company's \$4.10 to Nebraska City Utilities' \$10.89. Industrial rates ranged from the Black Hills Energy's \$8.08 to the City of Falls City's \$14.06.
