## **Chlorofluorocarbons in Household Appliances and Vending Machines**

This guidance document has been produced by the Nebraska Department of Water, Energy, and Environment (DWEE) to provide guidance in the disposal of household appliances and vending machines containing chlorofluorocarbons (CFCs). Most large household appliances are banned from landfill disposal in Nebraska. These appliances include all clothes washers and dryers, water heaters, heat pumps, air conditioners, dehumidifiers, refrigerators, freezers, trash compactors, dishwashers, conventional ovens, ranges, stoves, and wood stoves.

When these items are discarded and become waste items, DWEE recommends that they be recycled with special consideration given to the appliances that contain CFCs. Only a person who is trained and certified for recovery should remove CFCs. Refrigeration-type appliances delivered for recycling should have the CFCs removed or arrangements should be made to have the CFCs removed. DWEE recommends that appliances containing CFCs be segregated and stored to aid in the proper removal of the CFCs.

Vending machines are not considered a household appliance and are not subject to the land disposal ban. However, as they may contain refrigerant units, the CFCs should be removed as described above before recycling or disposal.
