- 1. Submit the completed application and citizenship attestation forms to NDEQ along with your payment by check or money order to be received no later than 30 DAYS BEFORE the testing date you plan to attend.
- 2. Approved applicants will receive an email within seven days following the application deadline date along with address, start time and exam site policy guidelines. Denied applicants will be contacted on a case by case basis within seven days following application submittal.
