INSTRUCTIONS

WHO MAY APPLY. Only legal residents of Nebraska may apply for loans. A legal resident is a Nebraska taxpayer, a Nebraska partnership, a Nebraska-chartered corporation, a subdivision of Nebraska government or a person who has maintained a permanent residence and lived in the state for more than six months. Residency requirements may differ for Energy Star® business or non-profit partners.

Getting Bids. You need to get bids or quotes first, so you will have them available for your lender. Make sure the contractor or supplier providing the bid or quote breaks all costs down by applicable item on this form. You are required to provide the estimated cost of each individual item, not a lump sum for all, or any combination of items. You are only required to get one bid or quote under the program, however, it is generally prudent to seek more than one to help you in your purchasing decision. Your lender may require more than one bid or quote in making certain types of loans.

Where to File. Take this completed form and the accompanying bids or quotes to your local lender for loan processing. If the lender of your choice is not participating in this program, contact the Nebraska Department of Environment and Energy (NDEE).

NAME, ADDRESS and BUILDING AGE. Print or type your name and mailing address in the space provided, and mark the age of the building in which the improvements will be installed. These improvements may not be installed in a building which is less than 5 years old.

DESCRIPTION OF IMPROVEMENTS. Check the box for the improvement you want to make and complete the information requested on that line. The estimated cost for projects on this form should be clearly broken out on the price

quote or contractor's proposal, and should be listed separately for each project on this form.

Line 8. Replacement windows and glass doors must meet requirements for measured performance or construction features. These requirements are listed on Form 2.3 Window/Door. Attach that form and documentation showing that the windows or doors meet the program requirements.

Line 9. Replacement doors must meet requirements for measured performance or construction features. These requirements are listed on Form 2.3 Window/Door. Attach that form and documentation showing that the doors meet the program requirements.

Line 12. If your wall insulation project includes new siding, you must complete and attach Form 2.2 Siding.

LineS 16, 17 and 18. Caution — when adding insulation, check ceiling load limits. If your attic or ceiling insulation project includes roof repair or a new roof, you must complete and attach Form 2.1 Roofing.

R-VALUES. R-values must be for the insulation material only, determined by proper ASTM testing as outlined in the FTC's "R-value Rule." R-value may not be included for reflective surfaces, air films, infiltration reduction or any other characteristics of the insulation other than the R-value of the material itself.

FUEL SUPPLIERS.
