For proposed issuance of a permit for Underground Injection Control (Permit number NE0210740). This proposed permit does not involve discharges to the land surface or surface waters of the State of Nebraska.

- CBR operates a commercial in-situ uranium mine (SIC number 1094). The specific operations involve extracting uranium using the in-situ mining process at the Crow Butte Uranium Facility owned by CBR. CBR has submitted an application for a Class III underground injection permit for a satellite facility, the North Trend Expansion Area (NTEA).
- 2. North Trend is located north of Crawford in Dawes County, Nebraska. The permit area covers an aerial extent of approximately 1,165 acres consisting of contiguous well patterns within the permit boundary. The production zone is the basal member of the Chadron Formation. The top of this unit of the Chadron Formation ranges from an approximate depth of 350 feet below ground surface at the northern and southern permit boundary to 700 feet below ground surface in the center of the permit boundary. Elevations range from approximately 3,750 feet to 3,630 feet above mean sea level. Excess water withdrawal (lixiviant bleed) will provide control of leachate movement. Monitoring wells will provide horizontal and vertical surveillance of groundwater quality thereby demonstrating confinement. The mining will consist of injection of a sodium carbonate/bicarbonate solution along with an oxidant (oxygen or peroxide) to the uranium-bearing formation through a pattern of injection wells. The uranium will be solubilized by the lixiviant and this solution will be pumped from the recovery wells to the satellite plant where the uranium is to be extracted by ion exchange. The lixiviant at the satellite facility will then be reconstituted with leaching agents and recycled to the well field for reinjection. Ion exchange will be used in the satellite facility, and the loaded resin from the ion exchange process will be transported to the main processing plant south of Crawford for extracting, drying and packaging of the uranium.
- 3. On the basis of preliminary staff review, the NDEQ has made a preliminary determination to issue the Class III permit for the NTEA.

June 22, 2011 in the auditorium at the Crawford Public High School and continuing as necessary. The public hearing will be conducted in accordance with Chapter 5, Title 115 – Rules of Practice and Procedure.
