Item 5. Program Report

Mr. Miesbach presented the program report that was included in the Board Packet. It outlined the declaratory orders/pre-notifications, violations, licensure information and testing information.

- Review of the program report.
- Dec Orders with Public Water System (PWS) encroachments, require engineering evaluation before approval. Education of the contractors have helped with potential issues with PWS, which has initiated more Dec Orders for the program.
- Free Nitrate sampling produced 500 samples over the 10ppm. Calls are going out to those with high results.
- The budget report was provided and discussed. Additional information was requested for review at the next board meeting. Mr. Miesbach will work with accounting to provide this information to the board in June.

Item 6. Legislative Report

- Budget was approved
- LB1317 appropriated one million dollars to NDEE to install real time nitrate sensors in monitoring wells statewide.
- LB937 unfunded real time nitrate management plan that NDEE is to develop jointly with NDNR. This bill passed out of committee but did not pass on the floor.

B. Department of Natural Resources – Mike Thompson

- Handouts of registration statistical reports were reviewed by the Board.
- Staff is spending about 25% of their time with the RO rebate program.
- The Wellhead Protection Area has been added to the interactive map.
- GIS feed to the NRDs is being deployed with PWS wells included.
- DNR would like to have the programmers from NDEE and DNR work together to provide access to NDEEs data base for the most up to date licensing information to DNR and Tyler Technologies simultaneously.

C. Dept. of Environment and Energy – Laura Johnson

- New Interim Director, Thad started three weeks ago
- New Drinking Water M&C Section Supervisor, Taylor Benzel started two weeks ago
- N Study (to assess the risk and provide solutions for nitrate impacted drinking water supplies)
 - Hoping to release the interim study soon
 - Presented updates at several conferences
 - Finishing up our final report, GIS tool, and outreach plan/tools

D. Natural Resources Districts – Lynn Webster

- NRDs are working on spring static levels, they are fairly flat due to precipitation last year.
- Tree season is keeping staff busy.
- Helping with well registrations for the RO system rebate program.

E. HHS – Division of Public Health – Russ Fosler

- 5000 kits were sent out for nitrate testing, still waiting on 1200 to be returned. The lab has been very busy providing these results.

Mr. Graf shared that people are wanting to become well drillers, they are taking the exams for licensing, however, have no experience in the field. Others are drilling their own wells because of the lack of contractors to do the work. He proposed that the state look at possible opportunities to help get more contractors into the business.
