A. UNL - Conservation & Survey - Sue Lackey

- New drillers helper has been hired. He is currently in training doing core work.
- Doug Hallum has taken a Water Resource Managers position with Lower Elkhorn. With the hiring freeze in place, Dr. Matt Joeckel is working hard to get this position filled.
- Jesse Korus did a demonstration at Ashfalls with the electric magnetic instrument towed by a four-wheeler (tTEM).
- Test-hole database work: Spatial projections (locations) of test holes are being standardized to NAD 83. Site-specific projects are also confirming and adjusting as needed older test-hole locations. The common adjustments are due to data entry errors and/or incorrect projections.

B. Department of Natural Resources – Mike Thompson

- Handouts of registration statistical reports were reviewed by the Board.
- Rate of registrations are slow right now.
- More use of online tools is providing more accuracy.
- Drought brings more calls in from domestic well owners about irrigation wells.
- DNR and NDEE merger, no information on timeframe.
